



CRITERIA & PROCEDURES FOR INDUCTION INTO THE IOWA BBQ SOCIETY HALL OF FAME

The Iowa BBQ Society Hall of Fame is intended to honor individuals, teams, businesses, local charities and/or celebrities who have distinguished themselves in the pursuit of recognizing barbeque as America's Cuisine, while celebrating, teaching, preserving & promote barbeque as a culinary technique, sport and art form.

Selection or induction is not guaranteed.

No more than 4 members will be inducted into the Hall of Fame in any given year. All inductees will receive an official Hall Of Fame notification letter, Hall of Fame Plaque a certificate and a lifetime membership in the Iowa BBQ Society.

Individuals or teams will be notified upon their selection.

The Iowa BBQ Society Executive Selection Committee shall consist of the current President, Vice President, Treasurer, Secretary and all board elected representatives. This committee will review and select all nominee requests for induction into the Iowa BBQ Society Hall of Fame.

The individual or team selection criteria are as follows:

Local, state or national recognition for outstanding achievement in barbecue excellence such as:

- BBQ Competitions
- Business & Industry
- Charitable Volunteering & Giving

All Hall of Fame applications must include the following:

- Nomination Letter
- Proof of Membership in the Iowa BBQ Society
- Name of Individual or Team
 - Mailing Address
 - City
 - State & Zip Code
- Individual Phone Numbers
 - Home
 - Work
 - Cell
- Biographical Sketch of Individual or Team
 - Limited to 1500 Words
 - Typed Format
 - No Abbreviations
